Scope of Work

Kutlwanong and Meloding townships have large numbers of houses with structural damage that was caused by sub-soil water.

It is requested that the cause of the rising sub-soil water be investigated and that a solution be found on how to solve or mitigate the impact of the sub-soil water on the civil structures.

The proposal should also include the impact that other civil engineering services like roads and storm water may have on the sub-soil water levels and how to solve or mitigate the impact.

The professional fees must include for the feasibility study, test bore holes, laboratory test, survey, design, compiling of tender documents, evaluation of tenders, contract administration (supervision and compilation of payments certificates) and compilation of final account.
