**COUNCIL RESOLVED (11 DECEMBER 2014)**

2. That the funeral of Councillor LC Mokausi **BE DECLARED** as a civic funeral of the Matjhabeng Municipality.

4. That the Executive Mayor, the Speaker and Municipal Manager **HANDLE** all matters relating to the cost of the funeral to Council and that the cost **MUST NOT EXCEED** the amount as stipulated in the Guidelines.
5. That Council **PROVIDES** transport to the funeral for Councillors, officials and other mourners.
6. The Municipal Manager **PROVIDES** a fire engine or arranges the hearse to the funeral.
