PURPOSE OF REPORT

To submit an unopposed motion by the Executive Mayor regarding the declaration of Cllr NE Mankayi's funeral as a civic funeral.

DISCUSSIONS

The Executive Mayor presented the item to Council.

COUNCIL RESOLVED (22 JULY 2010)

1. That the Council places **ON RECORD** its heartfelt sorrow at the passing away of Councillor NE Mankayi, a humble leader, loved by colleagues and the community of Matjhabeng.
2. That the funeral of Councillor NE Mankayi **BE DECLARED** a civic funeral of the Municipality Matjhabeng.
3. That Council **EXPRESSES** its heartfelt sympathy with the family of the deceased, relatives and friends.
4. That the Executive Mayor, the Speaker and Municipal Manager **HANDLE** all matters relating to the cost of the funeral to Council and that the cost must not exceed the amount of R180 000.
5. That Council **PROVIDES** transport to the funeral for Councillors, officials and members of the public.
