- 2. That the funeral of Mr M Tshivhidzo **BE DECLARED** a civic funeral of the Municipality Matjhabeng.
- 3. That Council **EXPRESSES** its heartfelt sympathy with the family of the deceased, relatives and friends.
- 4. That the contribution of Council **WOULD ONLY BE** towards the expenses of the funeral and **MUST NOT EXCEED** the amount of R180 000.

- 6. That the Municipality of Polokwane **BE OFFICIALLY INFORMED** of Council's resolution as the funeral of the deceased will be conducted in Polokwane.
