## **PURPOSE OF REPORT**

## **COUNCIL RESOLVED (7 MARCH 2012)**

2. That the funeral of Cllr ME Lande **BE DECLARED** a civic funeral of the Matjhabeng Municipality.
3. That Council **EXPRESSES** its heartfelt sympathy with the family of the deceased, relatives and friends.
4. That the Executive Mayor, the Speaker and Municipal Manager **HANDLE** all matters relating to the cost of the funeral to Council and that the budget for the funeral **MUST NOT EXCEED** the amount of R180 000.00, as per the Guidelines on Civic Funerals of Matjhabeng Municipality.
5. That Council **PROVIDES** transport to the funeral for Councillors, officials and other mourners.
6. That the Municipal Manager **PROVIDES** a fire engine or arrange the hearse to the funeral.
