# DRAFT MUNICIPAL ADJUSTMENT BUDGET (2016/2017) (EXECUTIVE MAYOR) (6/1/1/1)

#### PURPOSE

To submit to Council the Draft Municipal Adjustment Budget for the 2016/17 financial year in terms of Section 28 of the Municipal Finance Management Act No. 56 of 2003 and the Municipal Budget and Reporting Regulations.

#### DISCUSSION

The Executive Mayor presented the item to Council indicating that the adjustment budget was aimed at addressing fundamental issues and challenges in Matjhabeng, such as:

- economic empowerment of Matjhabeng community by ensuring that 70% of projects are awarded to benefit them;
- attraction of investors by creating an environment that is conducive for business;
- promotion of township tourism;
- promotion of sports such as boxing tournaments; and
- finding means of assisting needy students in order to help them to improve the living conditions of their families.

The Executive Mayor also highlighted that factors such as poor sanitation, high rate of crime, zama-zamas, illegal businesses etc. are discouraging investors from coming to invest in our area and therefore urged management and officials to keep all Matjhabeng areas very clean and attractive to investors.

The Executive Mayor informed members that the approved Annual Budget for 2016/17 financial year was based at 65% which was informed by the past collection trends but the actual pay rate for the first six months of the current financial year was 62%. He indicated that the consumer debt was R1.9 billion as from August 2016 to December 2016 and the debt of the business sector from August 2016 to date is R240 million.

In conclusion, the Executive Mayor emphasized that the Municipality should put rigorous debt collection efforts and credit control measures to improve revenue collection in order to prevent disconnection of services by ESKOM and Sedibeng. He urged all Councillors to encourage residents to pay for the services rendered and management to deal with businesses that owe the Municipality huge amounts for long periods as well officials who are tasked to disconnect services but fail to do so because of accepting bribes.

He also reported that the Municipality is experiencing 80% bypass of water and electricity and emphasized that urgent steps should be taken to curb such offenses.

To request Council for the approval of counter-funding for the Upgrading of Sewage Pumping Station; Outfall and rising main in Phomolong for which partial MIG funding was recommended by the Department of Water and Sanitation (DWS) as the Sector Department.
