PURPOSE

To submit to Council the upper limits of salaries, allowances and benefits of different members of Municipal Council as per Government Gazette No 39548 dated 21 December 2015.

DISCUSSION

The Acting Executive Mayor Cllr A Mbana presented the item to Council.

COUNCIL RESOLVED (12 JANUARY 2016)

- 1. That the increase of 5.5% for the Executive Mayor, Speaker, Whip, Mayoral Committee members and 6% for Part-Time Councillors, backdated from 1 July 2015, **BE APPROVED** with immediate effect.
- 2. That the increase **BE IMPLEMENTED** with immediate effect.
- 3. That the Executive Mayor **SHOULD GET** the same cell phone allowance as other members on grade 5.
