PURPOSE OF REPORT

4. That the contribution of Council would only be towards the expenses of the funeral and **MUST NOT EXCEED** the amount of R50 000,00.
5. That the Municipal Manager **ARRANGES** a fire engine or a hearse to transport the deceased to the graveyard.
