#### <u>FUNERAL : MR THE PIETERSEN, MUNICIPAL MANAGER, MATJHABENG</u> <u>MUNICIPALITY</u>(14/3/3) (AMM)

#### PURPOSE OF REPORT

- 1. To submit an unopposed motion by the Executive Mayor.
- 2. To submit a report to Council for approval of expenditure with regard to the funeral of the late Mr THE Pietersen.

#### DISCUSSIONS

The Acting Executive Mayor presented the item to Council.

#### COUNCIL RESOLVED (29 MARCH 2011)

- 1. That the Council places **ON RECORD** its heartfelt sorrow at the passing away of the Municipal Manager, Mr THE Pietersen, esteemed leader, adored by colleagues and the community of Matjhabeng.
- 2. That the funeral of Mr THE Pietersen **BE DECLARED** a civic funeral of the Matjhabeng Municipality.
- 3. That Council **EXPRESSES** its heartfelt sympathy with the family, relatives and friends, of the deceased.
- 4. That the contribution of Council **WOULD ONLY BE** towards the expenses of the funeral and must not exceed the amount of R180 000.
- 5. That the Acting Municipal Manager **ARRANGES** a fire engine or a hearse to transport the deceased to the graveyard.
- 6. That the Mangaung Municipality **BE OFFICIALLY INFORMED** of Council's resolution as the funeral of the deceased, will be conducted in Bloemfontein.
- 7. That Council **ARRANGES** the travelling of Councillors and Officials to the funeral.

8. That the Office of the Speaker **INTERACTS** with the Mangaung Municipality to make arrangements for the funeral and comply with protocol of a Civic Funeral of the Mangaung Municipality.
