REVIEWED INTEGRATED DEVELOPMENT PLAN AND ANNUAL BUDGET FOR MATJHABENG MUNICIPALITY FOR THE FINANCIAL YEAR 2014/2015(CFO) (6/1/1/1- (2014/15)

PURPOSE

To submit to Council the Reviewed Draft IDP and Draft Annual Budget for the 2014/2015 financial year as well as the related policies for approval.

The Executive Mayor further indicated that the following projects (Dr Mngoma Road and Phomolong sewer line) he omitted when he was presenting Reviewed Draft IDP and Draft Annual Budget for the 2014/2015 financial year.

DISCUSSION

The Executive Mayor presented points to note in the item to Council and in short, gave feedback to Council on compliance, basis for Operational Budget tariffs, realistic revenue collected, challenges, the Capital Budget summary and the Capital Budget challenges.

Having presented the Budget Speech, Members of various Political Parties thereafter expressed their views on the Budget and the proposed increases.

The opposition party (Democratic Alliance) objected the Property Rates increase and proposed that same should not be increased.

After a lengthy deliberation on the matter, the members could not reach an agreement and the matter was put to vote.

The voting was done by the showing of hands.

The votes were as follows:

- 1. 38 Councillors voted in favour of the proposed Property Rates increase
- 2. 12 Councillors voted against proposed Property Rates increase
- 3. 1 Abstain from voting
