<u>THE 2016-2017 ANNUAL BUDGET FOR THE MATJHABENG MUNICIPALITY</u> (CFO) (6/1/1/1)

PURPOSE

To table in Council the Annual Budget for the 2016/2017 MTREF financial year for adoption.

DISCUSSION

The Executive Mayor informed Council that Items A29/2016, A31/2016 and A32/2016 would be presented concurrently.

On his opening remarks, the Executive Mayor conveyed a message of condolences on behalf of Matjhabeng Municipality to the family of the late Mangaung Metropolitan Municipality Deputy Mayor, Me Connie Rampai who fatally passed on in a road accident, to the families of comrades who passed away on the same road while travelling from the ANC Manifesto launch in Port Elizabeth as well as to the family of Mr Muhammad Ali, a boxing icon who inspired many.

The Executive Mayor expressed his appreciation for the support and good working-relationship he received from the Speaker, Cllr Bhekumzi Stofile and applauded him on his skill in conducting Council meetings with such expertise, integrity and impartiality, equally treating every Councillor with respect, irrespective of political affiliation. He also thanked the Council Whip, Cllr MJ Twala, the members of the Mayoral Committee, leadership of all Political Parties, all fellow Councillors, the Municipal Manager, Management, Business, Media and Matjhabeng residents for their support during his term of Office.

The Executive Mayor indicated that the Budget was ward-based in line with the Integrated Development Plan which was developed through extensive interaction with the community of Matjhabeng during public participation processes.

He indicated that the Budget was aimed at ensuring that the frontiers of poverty and inequality were pushed back, highlighting some of the major developments that are planned, such as the joint development of a higher learning institution by Harmony Gold Mining Company Limited and POPCRU in Virginia as well as those that are completed, such as the opening of the Boitumelo Junction Mall in Thabong, developed at R254 million by Mr Mike Nkuna of the Masingita Group of Companies which created more than 500 jobs during construction and after completion.

The Executive Mayor also acknowledged the challenges faced by the Municipality such as decayed infrastructure which is a major contributor in water losses, insufficient revenue due to non-payment, illegal connections, cable thefts etc. and urged the community to work together with the Municipality by paying for services rendered and reporting illegal connections.

In conclusion, he assured the residents that the ANC-led Council will remain as committed as ever to ensure a better future for everyone and wished the incoming Council all the best.

The Executive Mayor indicated that the tariff rates for 2016/17 financial year would increase according to the following percentages:

- (a) Water tariffs would be increased by 6.6%
- (b) Electricity tariffs would be increased by 7.64%
- (c) Assessment rates would be increased by 6.6%
- (d) Refuse and sewerage rates would be increased by 6.6%
- (e) General tariffs would be increased by 6.6%.
