#### PURPOSE OF REPORT

To submit an unopposed motion by the Executive Mayor regarding the declaration of Cllr PP Thembani's funeral as a civic funeral.

#### **DISCUSSIONS**

The Executive Mayor presented the item to Council.

#### **COUNCIL RESOLVED (29 NOVEMBER 2011)**

- 1. That the Council **PLACES ON RECORD** its heartfelt sorrow at the passing away of Cllr PP Thembani, a humble leader, adored by colleagues and the community of Matjhabeng.
- 2. That the funeral of Cllr PP Thembani **BE DECLARED** a civic funeral of the Matjhabeng Municipality.
- 3. That Council **EXPRESSES** its heartfelt sympathy with the family of the deceased, relatives and friends.
- 4. That the Executive Mayor, the Speaker and Municipal Manager **HANDLE** all matters relating to the cost of the funeral to Council and that the budget for the funeral **MUST NOT EXCEED** the amount of R180 000.00, as per the Guidelines on Civic Funerals of Matjhabeng Municipality.
- **5.** That Council **PROVIDES** transport to the funeral for Councillors, officials and other mourners.
- 6. That the Municipal Manager **PROVIDES** a fire engine or arrange the hearse to the funeral.
