- 3. That the under-mentioned tariffs **BE APPLICABLE** for the 2010/2011 Budget Year:
 - a) **6%** increase in the water tariffs for the 2010/2011 financial year.

 - c) 8% increase in Assessment Rates (NOTE: This is not in terms of the Property Rates Act as the Valuation Roll is not accurate).
 - d) 4% increase in Refuse and Sewerage Rates.
