TO REQUEST COUNCIL'S APPROVAL ON THE ABSORPTION OF 95 MONTH-TO-MONTH CONTRACT WORKERS (ED: CSS) (5/3/1)

PURPOSE

The purpose of this item is to seek approval from Council in respect of the absorption of the 95 month-to-month contract workers with effect from 1st December 2015.

DISCUSSION

The Executive Mayor presented the item to Council.

COUNCIL RESOLVED (14 DECEMBER 2015)

- 1. That the 95 people **BE ABSORBED** and an internal advertisement be done by the Municipal Manager.
- 2. That in the event where there are those who do not meet the inherent requirements of the Post, the Employer **SHOULD DEVELOP** a Placement Programme for them.
- 3. That the Municipal Manager **MUST DEVELOP** a Re-Skilling Programme to address the category of unskilled employees within a period of three (3) years.
- 4. That the Municipal Manager **MUST NORMALIZE** all the abnormalities concerning the affected employees.
- 5. That this matter should **BE TREATED** as a special case and should not set precedence.
- 6. That the adjustment budget **MUST ADDRESS** the benefits of these employees in January 2016.
