**DETERMINATION OF UPPER LIMITS OF SALARIES, ALLOWANCES AND BENEFITS OF DIFFERENT MEMBERS OF MUNICIPAL COUNCIL (6/6/2) (CFO)**

**PURPOSE**

To submit to Council the upper limits of salaries, allowances and benefits of different members of municipal council as per Government Gazette No 33867, dated 10 December 2010.

**DISCUSSIONS**

The Acting Executive Mayor presented the item.

Cllr Styger moved that, due to the Municipality's financial position, the increase not be implemented.

Cllrs Motshabi and Montshioa opposed the motion and the Speaker highlighted the letter from the Minister for Cooperative Governance and Traditional Affairs whereby he determined the upper limits of the salaries, allowances and benefits of the different members of municipal councils.

**COUNCIL RESOLVED (21 DECEMBER 2010)**

1. That the Councillors' salaries, allowances and benefits **BE INCREASED** with immediate effect by 5%, backdated from 1 July 2010 as determined by the Minister of Cooperative Governance and Traditional Affairs.
2. That the tax allowance for all municipal councilors as permitted by section 8(1)(d) of the Income Tax Act, 1962, **NOT BE IMPLEMENTED** until there is clarity on the matter.
