APPROVAL OF THE BANKING FACILITIES OFFERED BY ABSA BANK LIMITED (6/14/1) (CFO)

PURPOSE

To submit to Council the banking facilities schedule offered by ABSA Bank Limited.

DISCUSSIONS

Cllr TW Dlova, on behalf of the Executive Mayor, apologized as the item should have served before Council some time back, but it couldn't.

Cllr Dlova presented the item to Council.

Cllr Van Rooyen indicated that the Municipal Manager and the Chief Financial Officer should be authorized to give instructions and to sign cheques, etc.

Cllr Montshioa explained that the overdraft must be paid in full at the end of the Financial Year to ensure that it starts clean in the new financial year.

COUNCIL RESOLVED (11 DECEMBER 2009)

That the Council **APPROVES** the banking facilities and overdraft facilities of **R10 000 000** for the 2009/10 financial year commencing 1 July 2009 to 30 June 2010 as follows:

1. That the municipality **OPENS/OPERATES** bank accounts with ABSA Bank Limited ("the bank") from time to time.
2. That the municipality **NEGOTIATES AND ACCEPTS** banking facilities and/or other banking services/products, including but not limited to electronic banking products and foreign exchange products, with the bank.
3. That the **Municipal Manager** or **Acting Municipal Manager** of the municipality **BE ENTITLED TO:**
 - (a) Request the Bank to open new or close existing bank accounts.
 - (b) Negotiate and settle the terms and conditions of the banking facilities/services/products on behalf of the client.
 - (c) Sign all documentation relating to 3(a) and 3(b) including but not limited to application forms, agreements, facility letters, security documents including but not limited to indemnities, surety ships, cessions, undertakings and mortgages.

- (d) Authorise individuals to give instructions to the bank, whether verbal, written, faxed or electronic, that may be necessary for the utilisation of the banking facilities/services/products.
 - (e) For purposes of electronic banking services, appoint system managers who will be responsible for registration of operators, registration of modules and authorisations per operator, linking accounts to operators, changing operator detail.
 - (f) Authorise individuals to sign cheques, bills of exchange, promissory notes, other negotiable instruments, documentation relating to deposit and withdrawal of funds in any bank account.
4. That the Executive Mayor be authorised to supply the bank with the names and specimen signatures of the persons authorised pursuant to 3 above.
