NATIONAL UNION OF MINEWORKERS: APPLICATION TO ERECT MONUMENTS ON MUNICIPAL LAND (20/9/1) (EDI)

PURPOSE OF REPORT

The purpose of the report is to motivate the allocation of land to the National Union of Mineworkers to erect three monuments on Municipal land viz.:

- Welkom: Central Park Erf 206 / 86
- Odendaalsrus: Park area of the Municipal Offices
- Virginia: Virginia Gardens

DISCUSSIONS

COUNCIL RESOLVED (6 DECEMBER 2012)

- 1. That the National Union of Mineworkers (NUM) **BE PERMITTED** to erect monuments on the following portions of Municipal land:
 - a) Welkom: Central Park Erf 206 / 86
 - b) Odendaalsrus: Park area at the Municipal Offices
 - c) Virginia: Virginia Gardens

- 2. That the placement and planning of construction of the monuments **BE DONE** in consultation with and to the satisfaction of Parks and Recreation and that all costs associated with any municipal services required will be for the applicant.
- 3. That Council **ENTERS INTO** a Service Level Agreement with the National Union of Mineworkers with regard to the maintenance of the areas allocated for the monuments.
- 4. That a servitude **BE REGISTERED** in Council's name on the portions of land allocated to the National Union of Mineworkers for the erection of the monuments.
