	The Chief Magistrate, Ms A. Motlekar administered the taking of oath by 70 of the newly elected Councillors for Matjhabeng Local Municipality.

( <b>f</b> )	Motions of congratulations from the Municipal Manager
	The Municipal Manager, on behalf of Matjhabeng Municipality congratulated Cllr B. Stofile on his election as Speaker for the second term in succession, and indicated that he was greatly honoured to serve under such a leader of such high calibre.
	He also conveyed a message of condolences to the Stofile family for the passing away of his brother, Rev. Makhenkesi Stofile, the former Minister of Sports & Recreation who was currently serving as an Ambassador to Germany.
