# **Opening** (a) The Speaker welcomed everybody present at the 3<sup>rd</sup> Special Council meeting of the year 2017 and declared the meeting open. **Applications for leave of absence (b)** See Councillors' attendance list on page I of these minutes. Official announcements of the Speaker (c) The Speaker informed members that he had received a letter from EFF attorneys, namely Kwinana & Partners, which indicated that Council was illegally preventing the EFF Councillors from coming to Council meetings and based their opinion on the Buffalo City Court Order solicited by EFF. The Speaker stated that in his view the Buffalo City Order might be issued on different facts compared to Matjhabeng Council's facts. He reminded members that the Standard Rules and Orders were formally adopted collectively by Council as rules that would govern the business of Council and the rules state that every member should adhere to the approved dress code with no exception to anyone. He further stated that until such time that there is a ruling that sets aside the adoption of Matihabeng Council's Standard Rules and Orders, no member who is wearing his/her regalia or uniform related to any Political Party would be allowed in Council meetings. He told members that upon receipt of any communication, the Municipality however, has legal responsibility to reply to the issues raised and therefore they are committed to respond to the issues raised by the EFF Attorneys. He thereafter requested the EFF Councillors to abide by the rules, as his role as Speaker, among others, was to enforce the rules and if they refuse to abide by the rules, they should recuse themselves. Cllr MT Macingwane stated that the EFF objected to the adoption of the Standard Rules and Orders and therefore believed that they should be allowed to stay. He based his statement on the meeting held on 06 September 2016. The Speaker corrected him and stated that their objection was on the establishment of the Rules and Ethics Committee reflected as Item A64/2016 in the minutes of that meeting and not on the Standard Rules and Orders reflected as Item A68/2016. After several inputs from EFF members regarding the matter, the Speaker ruled that the

members of EFF should recuse themselves from the Council Chambers due to the

contravention of the approved dress code.

#### **PURPOSE**

- 2. That the second highest candidate **BE APPOINTED**, should the recommended candidate fail to assume his responsibilities for any reason.
- 3. That Council **DELEGATES** the Executive Mayor the function of negotiating the remuneration package with the appointed Municipal Manager and must report to Council for finalization.
- 4. That Council delegates the Executive Mayor **TO FINALIZE** the contract of employment, performance agreement and financial disclosure form with the appointed Municipal Manager.
