After lengthy debate on this matter, Cllr TS Majoe requested that his objection against the proposed resolution be noted.

IT IS RESOLVED BY COUNCIL : 11 JULY 2001

1. That Council **WITHDRAW** any previous permission or approval (whether expressed or implied) which was given to Public Transport Operators (Taxi Operators) to use Stand 7886 in Welkom as a taxi terminus.
2. That all Public Transport services and/or taxi operations of whatsoever nature **ARE PROHIBITED** on Stand 7886, Welkom.
3. That Public Transport vehicles and/or taxis **ARE PROHIBITED** from entering or using Stand 7886, in Welkom for purposes of loading-or off loading passengers and their goods.
4. That the Chief Traffic Officer **ENSURES** that applicable traffic signs **BE ERECTED** at strategic places, amongst others, the entrances to Stand 7886 clearly indicating the aforesaid prohibition.
5. That the Chief Traffic Officer **TAKES** the necessary steps to have transgressors of the by-laws in this regard **BE PROSECUTED** in terms of existing law.
