PURPOSE OF REPORT

To submit an unopposed motion by the Executive Mayor regarding the declaration of Cllr MC Majwede's funeral as a civic funeral.

COUNCIL RESOLVED (09 SEPTEMBER 2008)

1. That the Council places **ON RECORD** its heartfelt sorrow at the passing away of Councillor MC Majwede, a humble leader, adored by colleagues and the community of Matjhabeng.
2. That the funeral of Councillor MC Majwede **BE DECLARED** a civic funeral of the Municipality Matjhabeng.
3. That Council **EXPRESSES** its heartfelt sympathy with the family of the deceased, relatives and friends.
4. That the Executive Mayor, the Speaker and Municipal Manager **HANDLE** all matters relating to the cost of the funeral to Council.
5. That Council **BE ADJOURNED** until Sunday, 14 September 2008.
6. That the Municipal Flags at all Municipal Offices **SHOULD BE** hoisted at half mast to observe the solace occasion in respect of the late Councillor MC Majwede from the 9th September 2008 until the 14th of September 2008.

Before the recommendation were discussed:

The Executive Mayor explained to the Council that they did not indicate the financial implication of the funeral due to the fact that they are still busy interacting with the family of the late Councillor MC Majwede, and they are still waiting for the feedback from the preparatory Committee with regard to the quotations from the different funeral Parlours.

Councillor (Dr) J Marais (DA) put the proposal that the expenditure for the funeral should be up to R80 000, 00.

Councillor BA Montshioa proposed that the amount of R180 000, 00 which was spent on the last two civic funeral be used as a benchmark and be applicable to Councillor

MC Majwede's funeral.

Councillor (Dr) J Marais then withdrew his proposal and agreed with Councillor BA Montshioa on his proposal.
