#### IT IS RESOLVED BY THE COUNCIL: (28.08.2001)

That the application for special consent in terms of Clause 30 of the Welkom Town Planning Scheme, No 1/1980 to conduct a place of entertainment (sportbar, dancing and pool tables) of 1500m<sup>2</sup> from Erf 6416, Extension 8, Welkom **BE APPROVED SUBJECT** to the following conditions:

- (a) This consent shall come into effect only after the applicant applied for the removal of restrictive title conditions C (o) (i) and (ii) and D (c) in Deed of Transfer T117/1995 and the removal is approved by the MEC.
- (b) A maximum of 1500m² of the building on Erf 6416 may be used for a place of entertainment.
- (c) The development and use of the erf shall be subject to all applicable regulations of the Council.
- (d) No goods of any kind shall be displayed or sold outside the building.
- (e) Where the consent of the Council is obtained and not substantially implemented within six (6) months after notification of the Council's decision, or development or use of the building or land is interrupted for a period of three (3) months or more, the consent granted shall lapse automatically and cease to be valid without any claim for compensation.
- (f) Suitable and easy accessible toilet facilities shall be provided on the premises to the satisfaction of the Council.
- (g) Noise reduction measures shall be taken to the satisfaction of the Council in order to prevent the noise from the place of entertainment to cause a nuisance for the inhabitants of the flats and houses in the vicinity of the erf.
