<u>OPERATING BUDGET : 2001/2002 FINANCIAL YEAR (6/1/2/1-2001/2002)</u> (TMFS)

The Executive Mayor Cllr. SJ Leeuw presented the budget to Council and requested that Council approve it.

The Speaker gave an opportunity to selected members of Section 79 Committees from the different political parties to address Council on the budget.

After extensive deliberations the matter was put to vote and the result was as follows:

For approval of the budget : 50 Against the approval : 12 Abstention from voting : 2

IT IS RESOLVED BY THE COUNCIL: (29.05.2001)

- 1. That the Operating Budget comprising expenditure of R533 209 811 and income R533 209 811, as reflected in Annexure B of the agenda of Council dated 29 May 2001, **BE APPROVED** as the Council's Operating Budget for the financial year 2001/2002;
- 2. That the Operating Budget approved in paragraph (1), **BE SUBMITTED** to the Director-General of Finance for approval;

That the domestic electricity tariffs (**WILL BE** R0,255 per kwh) **WITH EFFECT** from 1 July 2001.

4. That due to increase in operating expenditure, as well as an expected increase of 10% in the price of water from 1 July 2001, all the Council's current water user tariffs BE INCREASED AS FOLLOWS:- WITH EFFECT from 1 July 2001.

Water

- 0 6 kl free for residential users
- 0 6 kl R7.55 all other users excluding residential users.
- 7 50 R7.55 all consumers (excluding. Schools and Churches)
- 7 50 R6.40 School and Churches
- 51 higher R10.00 all consumers
- 5. That the refuse removal tariffs for all categories of users of the service **BE INCREASED** with effect from 1 July 2001 by 12%, and that all existing rebates, remissions, or discounts previously allowed to certain users of the services **BE ADJUSTED** to accommodate the increase:
- That assessment rates levied on all classes of property within Council's jurisdiction WILL BE INCREASED AS FOLLOWS WITH EFFECT from 1 July 2001.

Assessment Rates:

- 0,14824 Residential
- 0,22235 Business
- 0,22735 Industry
- 0.07412 Agricultural
- 7. That the sewerage tariffs/charges **BE INCREASED** with effect from 1 July 2001, by 12%, and that all existing rebates, remissions, or discounts previously allowed to certain users of the service **BE ADJUSTED** to accommodate the increase;
- 8. That the Municipal Manager **ENSURE** that in giving effect to paragraphs 3 7, all requirements necessary to ensure that the Council complies with relevant legislation, including NER directives, **ARE COMPLIED** with;
- 9. That the relevant by-laws / tariffs **BE AMENDED** accordingly.
