REPORT OF THE AUDITOR-GENERAL TO THE COUNCIL OF THE MATJHABENG LOCAL MUNICIPALITY ON A FORENSIC AUDIT INVESTIGATION INTO ALLEGED IRREGULARITIES AT THE MATJHABENG MUNICIPALITY

#### BACKGROUND

The Executive Mayor presented the Forensic Report from the office of the Auditor-General reminding Councillors that the report emanated from a resolution of Council after considering the Audit Reports of the various disestablished Municipalities.

He highlighted the following from the report:

- 1. That the former Municipalities did not have proper controls in place and where there were controls, they could be manipulated by officials to their benefit.
- 2. That the Forensic Report serves as a discussion document and does not express guilt or innocence of any person or party but merely state facts and that in a civil, criminal litigation and disciplinary hearings the document may only be used as a background document.

## COUNCIL RESOLVED: (31 MARCH 2005)

- That in terms of the Standing Rules and Orders of Council an Ad hoc Committee BE CONSTITUTED TO INVESTIGATE the fundings of the Auditor-General.
