#### 14.1.1 Rural Councils in Matjhabeng

Councillor Smit informed Council that the previous Rural Councils in the Matjhabeng Area were handled by the Goldfields District Council. Various funds from the Provincial Government have been paid into the Council's account. After the amalgamation, the Rural Councils are no longer under the jurisdiction of the District Council. Councillor Smit would like to know how is the Matjhabeng Municipality addressing the people in the Rural areas who fall within the Matjhabeng area and how the said people are given access to the municipal services in accordance with the equitable share allocation ?

#### 14.1.2 Parks and Health Department (Virginia Area)

Councillor Smit informed Council that on page 26 of the Executive Mayor's report, it is mentioned that there are 26 tractors but, only 11 are operational. He mentioned that the community is complaining about the poor state of the open spaces in town as well as the poor state of the pavements. Councillor Smit requested that the Parks Department submit a comprehensive report to Council regarding this poor service and how it will be addressed, as well as to explain why the equipment is not fixed ?

#### 14.1.3 Financial Report

Councillor Smit informed Council that Council was promised that the financial report would be submitted during October 2001. He mentioned that Council cannot gauge its financial status without proper financial reports. Councillor Smit would like to know why the financial report is not accessible yet and when will it be accessible. The report must address how many people are paying for their municipal services accounts and when do they pay them, as well as why the suppliers of goods to the municipality are not paid their accounts on time ?

#### 14.1.4 Reports of the Mayoral Committee Members

Councillor Smit reports that the Mayoral Committee Members reports are not timeously submitted nor made available to other Councillors, in order for them to establish Council's performance. He also mentioned that the Mayoral Committees's reports do not entail enough information regarding issues discussed. Councillor Smit requests that a possible system should be investigated to fast-track the availability of information to Councillors on a monthly basis ?

# 14.1.5 Communication between Lejweleputswa Council and Matjhabeng Council

Councillor Smit mentioned to Council that communication between the 2 organisations is very poor. He mentioned that Lejweleputswa Council only has quarterly meetings, with the result, that Councillors get information from them after every three months. Councillor Smit would like to know what line of communication has been taken between Lejweleputswa and Matjhabeng Municipality?

#### 14.1.6 Report-back regarding the Ambulance Services

Councillor Smit informed Council that he posed questions to Council regarding the poor ambulance service a while back, which have not been addressed by Council as yet. Councillor Smit also mentioned to Council, that the Council meeting is the only platform that a Councillor has to speak on behalf of the community. Councillor Smit further mentioned that the community has the right to a better ambulance service. Councillor Smit requests Council to take the issue up with the Province ?

#### 14.1.7 Cleanliness and access control to the Main Building (Welkom)

Councillor Smit is of the opinion that loitering of the people occur at the main building of Matjhabeng Council in Welkom. He is also of the opinion that better access control should be addressed urgently. Councillor Smit mentioned the poor state of the toilet facilities. Councillor Smit requests that the access control to the building must be improved as well as the information service ?

#### 14.1.8New Traffic Contract

Councillor Smit requested that a comprehensive report with regard to the new traffic contract be submitted to Council with specific reference to the financial implications thereof and what the contract entails ?

#### 14.1.9 Church Mission Work in the Wards

Councillor Smit informed Council that a certain church group was ministering in a particular Ward, and was approached by a person who claims to be the Ward Councillor. This person stopped the ministering in the Ward and said to the church group that he is the person that can grant them permission to do the ministering in the Ward. Councillor Smit would like the other Ward Councillors to take note of this incident.

#### 14.1.10 Tswelelopele Africa Finance

Councillor Smit requested that a total internal audit of Tswelelopele Africa Finance be submitted to Council as well as who are the people involved in the company ?

The response to Councillor DC Smit's questions is attached as **Annexure "A".** 

- **14.2** CIr T.E. Thoabala wanted to know from CIr MP Motshabi (UDM) in terms of Rule 53(b) of the Standard Rules and Orders :
  - Why he jumped the fence at the hall in Kutloanong?
  - To what extent he was involved in a campaign to illegally re-connect water of the residents of Kutloanong as well as what his stance is in this regard as a UDM Councillor ?
  - **Answer :** The Councillor responded that the reason he jumped the fence was because he was denied access to the hall.
    - The illegal reconnections in Kutloanong is a UDM Campaign. Council should take it up with the party structures.
    - He refuses to say what his stance is as a Councillor on this campaign.
