**REPORT: SPEAKER: ALLEGATIONS LAID AGAINST CLLR SE TSHABANGU: PHOMOLONG PUBLIC DISTURBANCES (4/1/4/6) (SPEAKER)**

**PURPOSE**

To submit a report of the Speaker in terms of Chapter 8, Rule 99(4)(a) of the Standing Rules and Orders of Council with regard to allegations laid against Cllr SE Tshabangu to Council.

The Speaker read the letter received from Cllr Tshabangu's attorneys for the record.

The Speaker informed the Council that due to the fact that the response from Cllr Tshabangu was by way of a letter received from his attorneys and not a statement made by himself, he was unable to make a finding and proposed that the matter be further considered by Council.

2. That Cllr SE Tshabangu **BE SUSPENDED** for the duration of the investigation to be conducted by an independent committee in terms of Rule 100(7)(c) of the Standing Rules and Orders.
3. That further allegations as raised **BE REFERRED** to the relevant institutions.
4. That Council **MANDATES** the Speaker and the Executive Mayor to appoint the independent committee and report at the next Council meeting on the appointment of that committee.
5. That financial provision **BE MADE AVAILABLE** to execute the investigation.
