  - (ii) Subdivision 1 of the farm Homestead 688 (± 171,3ha)
  - 2. That only the transfer costs be BORNE by Council.
  - 3. That the business plan, as well as the Council's liability regarding the project be submitted to the Mayoral Committee.
  - 4. That the resolution of the FGF regarding the establishment of a Paprika industry in Matjhabeng be submitted to the Mayoral Committee.
  - 5. That a clause be added to the contract between Council and the FGF ensuring that in case the FGF wishes or is compelled to dispose of the above-mentioned land, the land be transferred back to Council.
