<u>APPOINTMENT : THE CORPORATE EXECUTIVE MANAGER : FINANCIAL</u> <u>MANAGEMENT</u> (5/3/2/3) (EMHR) (P1 : ANNEXURES P 1 - 10)

During the discussions of the item, the DA, UDM and PAC political parties rejected the appointment of Mr RN Pitso as the Corporate Executive Manager : Financial Management for the Matjhabeng Local Municipal Council and cited the following reasons :

- 1. They disassociated themselves from any actions that will be taken by the incumbent of the position because they did not get the documentation pertaining to the applicants, timeously.
- 2. They refused to accept responsibility for the appointment of the incumbent because they did take part in the interviews of the short-listed candidates, hence there was no transparency on the appointment of the candidate.

The Municipal Manager responded that all the political parties where furnished with the list of all the applicants for the positions of the Corporate Executive Manager as well as the Executive Manager Financial Management, respectively through the office of the Executive Manager : Human Resources albeit late. The long- and the shortlisted candidates were circulated to all the political parties in the Municipality.

Councillors (Dr) JS Marais and DC Smit spoke on behalf of the DA, whilst Councillor MP Motshabi and TS Majoe spoke on behalf of the UDM and PAC, respectively.

Council TD Khalipha responded on behalf of the ruling party, ANC, and mentioned that the Council must adopt the recommendation of the Special Mayoral Committee as resolved at its meeting held on 22 January 2003, whilst also emphasizing that the allegations of the DA, UDM and PAC were exactly true that they did not receive the documentation of the candidates timeously, in the light of what Mr Sesele said. He further mentioned that all Councillors should take full responsibility and accountability for the appointment as the ANC has done, whereafter :

COUNCIL RESOLVED : (28 JANUARY 2003)

- **[EMHR]** 1. That Mr Pitso **BE APPOINTED** as the Corporate Executive Manager : Financial Management.
- **[EMHR]** 2. That the recommended employee referred to in paragraph 1 above, **COMMENCES** with his duties not later than 3 March 2003.
