<u>REPORT ON FINDINGS BY THE OVERSIGHT COMMITTEE BASED ON THE</u> <u>MATJHABENG MUNICIPALITY'S ANNUAL REPORT 2006/2007</u> (4/1/2/2)

PURPOSE

To submit to Council the report on findings by the Oversight Committee based on the Matjhabeng Municipality's Annual Report 2006/2007.

//The Speaker requested that Item SA2/2008 be dealt with first to give the Chairperson of the Oversight Committee, Cllr Motshabi, the opportunity to present the report on the findings on the Annual Report as tabled during January 2008. The Annual Report was submitted to the community for participation.

Cllr Motshabi presented the report compiled by the Oversight Committee and thanked all members of the Oversight Committee on work well done as well as the members of the public for their assistance. Cllr Botha, member of the Oversight Committee, stated that the report was not the report of the Oversight Committee as Cllrs Motshabi and Matlabe were supposed to write a preliminary report which would be circulated amongst the members of the Oversight Committee for their inputs, which never materialized. He requested that the report be referred back for the Oversight Committee to compile a proper report before submission to Council.

The Executive Mayor raised a concern on the report as the MFMA required that within two (2) months after the Annual Report was submitted to Council, which was done during January 2008, the Oversight Committee must table their report. Members of the Oversight Committee should have interacted with the Chairperson of the Oversight Committee on the matter after they have received their agendas and requested that the item be withdrawn.

COUNCIL RESOLVED (16 APRIL 2008)

That the Oversight Committee's Report **BE REFERRED BACK** for finalization and submission at the next Council meeting.

SA3/2008

RESIGNATION OF THE MUNICIPAL MANAGER (Executive Mayor) (5/8/2)

PURPOSE

To request Council to consider the resignation of the Municipal Manager.

The Executive Mayor thanked Dr Malakoane for achievements as it was evident that many changes took place since he arrived. There were still many challenges to be addressed.

COUNCIL RESOLVED (16 APRIL 2008)

- 1. That the resignation of the Municipal Manager, Dr B Malakoane, **BE ACCEPTED** with effect from 1 May 2008 to allow him to pursue personal growth.
- 2. That the contract with Dr B Malakoane **BE TERMINATED** from 1 May 2008 by mutual agreement.
- 3. That the post of Municipal Manager **BE ADVERTISED** as soon as possible.

4. That a special Council meeting **BE HELD** to appoint an acting Municipal Manager for the interim.
