# SALE OF REMAINDER AND SUBDIVISION 3 OF ERF 8 WELKOM (8/3/2/10) (MM)

#### **PURPOSE**

To request Council to reaffirm the resolution taken on 2 November 2004 under item SA18/2004.

After lengthy discussions on the matter the DA requested a caucus which was granted. A second caucus was requested by the DA whereafter they requested that the item be referred back until after the outcome of the Court Case.

#### The matter was put to the vote:

53 votes supported the proposal by the Executive Mayor.

9 votes supported the proposal by Councillor (Dr) JS Marais.

Seeing that no consensus was reached the Speaker put the matter to the vote.

# 51 votes supported the proposals by the Executive Mayor 9 votes supported the proposal of the DA

#### **COUNCIL RESOLVED (20 AUGUST 2008)**

- 1. That Council **NOTES** that the High Court nullified the Deed of Sale that was signed between Council and Ixhanti Lethu.
- 2. That Council **RESCINDS** the decision of resolution SA 18/2004 to sell remainder and subdivision 3 of erf 8 to Ixhanti Lethu.
- 3. That Council **REAFFIRMS** the resolution to sell remainder and subdivision 3 of erf 8 as it was already zoned for business type E and therefore not needed for basic municipal services.
- 4. That the pump-station on the erf **REMAINS** municipal property and therefore not be part of the sale agreement.
- 5. That the reserve price of R85/m<sup>2</sup> BE ACCEPTED.

- 6. That the Accounting Officer **BE MANDATED** to sign the Deed of Sale of remainder and subdivision 3 of erf 8 pending the outcome of the court case and the preferred developer be compliant with the BEE prescripts.
- 7. That the **RELOCATION** of the sport facilities on the said property **BE FOR THE COST** of Council.
