



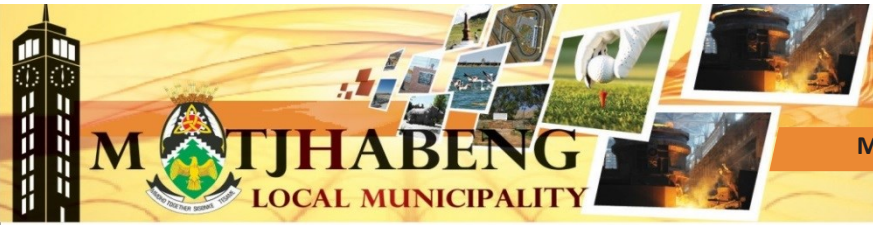

Only cash or bank guaranteed cheques will be accepted and cheques are to be made payable to **Matjhabeng Local Municipality**.

Bids must be completed in accordance with the conditions and bid rules contained in the bid documents and be sealed, together with supporting documents, in an envelope or package clearly marked with the **Tender Bid Number and Tender Name/Description** and be placed in a bid box situated at the main entrance of the Municipal Civic Centre, 319 Stateway, Welkom, **not later than 14H00 on 03 October 2017**. No faxed, e-mailed or late bids will be accepted.

Bidders' attention is specifically drawn to the provisions of the bid rules and evaluation criteria which are included in the bid documents. The lowest or any bid will not necessarily be accepted and the Council reserves the right not to consider any bid not suitably endorsed or comprehensively completed, as well as the right to accept a bid in whole or part. Bids completed in pencil will be regarded as invalid bids. Bids may only be submitted on the Bid Document provided by the Matjhabeng Local Municipality.

The following information must be submitted together with the bid document: **Original and Valid Tax Clearance Certificate with Tax Compliance Status (SARS Pin), copy of Company Registration Certificate, certified copies of IDs of Directors, copy of valid Workmen's Compensation Certificate, proof of CSD registration, copy of proof of payment for Municipal Services and other compulsory documents stated in the Bid Document. Please note that these documents must be submitted for each company in case of Joint Venture or Partnership. Bidders are required to submit certified-BBEE Verification Certificate with SANAS Logo, for exempted Micro Enterprise (EME) must submit certificate issued by registered auditors, accounting officers with practice Number or accredited verification agency in order to claim preferential points. Bidders will be evaluated according In terms of the Preferential Procurement Policy Framework. The vehicles offered shall comply in all respect to the requirements of the SABS/SANS Compulsory specifications applicable to the vehicle category concerned.**
