Certified Copy of Company Registration Certificate reflecting names and identity numbers of active shareholding must be attached (Except for sole traders and partnerships). 4. Copy of JV agreement (in case of JV) must be attached. 5. Municipal Rates & Taxes Clearance Certificate not older than 30 days or a lease agreement must be attached. 5. All supplementary / compulsory forms contained in the bid document must be completed and signed in full. 6. Failure to comply with the above mentioned conditions may invalidate your bid. 7. Bidders must attach certified or original BBBEE Verification certificate in case of Joint Venture bidders must submit consolidated BBBEE score card.
